

### **3-Step Process**

To demonstrate whether products are conflict-free, information must be captured and centralized from numerous content providers early in the supply chain. The Inspirage **Conflict Minerals Solution** can help by performing the following three functions:

- 1. Data acquisition and integration: Inspirage provides adapters that integrate data from a variety of sources. We provide an adapter to the EICC Manufacturer Declaration forms that all suppliers must complete. We also provide adapters to Total Parts Plus and IHS that can extract data out of the particular systems to support full disclosure for components and obsolescence. The TPP Adapter can also retrieve supplier EICC forms if available.
- 2. Data definition and management: Our solution checks business rules and validations against the data to determine whether or not a particular product is conflict-free based on the information your supplier has provided in the EICC form. We also aggregate this information to provide a summary view of individual suppliers and their associated manufacturer parts.
- 3. Reporting: Once the data has been acquired, you can quickly see if each product is compliant, not compliant, or if more information is necessary. The system regenerates the information every time you get new data in to enable you to do that proper analysis. With this information, you can easily report your status to customers or the governing agencies.



### Building a Repeatable, Scalable Process

The Inspirage solution helps companies deal with a dynamic environment of constantly changing players. 
